**Subject: Combined Hindi Translators Examination, 2025 – Declaration of result of Paper-II to shortlist candidates for PET/PST for the post of Sub Inspector (Hindi Translator) in CRPF.**

Result of Paper-I of Combined Hindi Translators Examination, 2025 was declared on 04.11.2025. A total of 3642 candidates were shortlisted in Paper-I for appearing in Paper-II of the examination. Subsequently, Paper-II of examination was conducted on 14.12.2025.

2. As per Para 16.3 of Notice of exam, minimum qualifying marks in Paper-II of the examination has been fixed by the Commission as under:

- i. UR: 30%
- ii. OBC/EWS: 25%
- iii. All Other Categories: 20%

3. Candidates who have opted for CRPF in their online application form of examination, have been shortlisted for appearing in PET/PST examination to be conducted by CRPF for the post of Sub Inspector (Hindi Translator).

4. As per Para 2.3 of the Notice of exam, *the post of Sub Inspector (Hindi Translator) in Central Reserved Police Force is not identified suitable for any category of PwBD/PwD.* Hence, those PwBD/PwD candidates who appeared in Paper-II and have opted for the post of Sub Inspector (Hindi Translator) in CRPF have not been shortlisted.

5. The candidates who fail to qualify PET/PST will not be considered for the post of Sub Inspector (Hindi Translator) in CRPF. However, if such candidates get shortlisted for other posts mentioned in the Notice of Examination, their candidature will remain valid for these posts. Final result for the post of Sub Inspector (Hindi Translator) in CRPF and all remaining posts will be declared at a later stage after completion of PET/ PST for the post of Sub Inspector (Hindi Translator) in CRPF.

6. Category-wise breakup of candidates provisionally shortlisted for appearing in PET/PST for the post of Sub-Inspector (Hindi Translator) on the basis of their performance in Paper-II of the exam is as follows:

7. The schedule of PET/PST for the post of Sub Inspector (Hindi Translator) in CRPF will be published on website of the Commission in due course.

8. Further, it is also informed that Commission will obtain Option-cum- Preference before the declaration of final result of the exam. A Notice seeking Option-cum-Preference from the candidates will be published on website of the Commission in due course. Candidates are advised to visit the Commission's website and also website of the Regional/Sub-Regional offices at regular intervals for further updates. Candidates may note that in case they fail to submit their post preference(s) on the website of the Commission within the stipulated window, they will not be considered for any post in the Final Result.

9. Marks of the qualified/non-qualified candidates will be uploaded on the website of the Commission after declaration of the final result of the examination.
