Stenographer Grade 'C' and 'D' Examination, 2025- Declaration of First Round of Tentative Allocation (FRTA)–reg

The Staff Selection Commission declared the result of Computer Based Examination of Stenographer Grade 'C' and 'D' Examination, 2025 on 28.11.2025. In the said result, a total of 8624 candidates were declared qualified for appearing in Stenography Skill Test for the post of Stenographer Grade 'C' and 22456 candidates were declared qualified for appearing in Stenography Skill Test for the post of Stenographer Grade 'D'. 4907 candidates appeared in the Stenography Skill Test for the post of Stenographer Grade 'C' and 12564 candidates appeared in the Stenography Skill Test for the post of Stenographer Grade 'D'.

2. First Round of Tentative Allocation (FRTA) has been done in accordance with the Notice dated 03.03.2026 on introduction of Sliding Mechanism for qualifying candidates.

3. In accordance with the Notice No. E/16/2025-C-2 SECTION-Part(1) dated 05.05.2026 of the Commission, Option-cum-preference has been taken online from **05.05.2026 to 08.05.2025** from the candidates, who had appeared in Stenography Skill Test Examination. Accordingly, 10,132 candidates who have submitted their preference online have been considered for further selection process.

4. Commission has fixed the category wise cut-off on percentage of error/ mistakes allowed in Skill Test as under:

- i) **Stenographer Grade 'C'**: upto 5% mistakes for UR and upto 7% mistakes for all reserved category candidates.
- ii) **Stenographer Grade 'D'**: up to 7% mistakes for UR and up to 10% mistakes for all reserved category candidates.

5. As per the provisions of Notice of Examination, allocation of Posts and Departments has been made on the basis of merit-cum-'order of preference' of 'Posts/Departments' submitted by the candidates online. Candidates have been provisionally shortlisted for **First Round of Tentative Allocation (FRTA) for** the post of Stenographer Grade 'C' &'D' in different Ministry/Departments/ Offices as given below:
