Subject: Junior Engineer (Civil, Mechanical & Electrical) Examination, 2025- Declaration of First Round of Tentative Allocation (FRTA).

The Staff Selection Commission declared the result of Paper-I of Junior Engineer (Civil, Mechanical & Electrical) Examination, 2025 on 06.03.2026, wherein a total of 15,607 candidates were shortlisted to appear in Paper-II of the Examination. A total of 14062 candidates appeared in Paper-II, which was conducted on 07.04.2026.

2. First Round of Tentative Allocation (FRTA) has been done in accordance with the Notice dated 03.03.2026 and 08.04.2026 on introduction of Sliding Mechanism for qualifying candidates.

3. As per the Notice No. HQ-C-3019/2/2025-C-3 dated 10.06.2026 of the Commission, Option-cum-preference was sought from 10.06.2026 to 14.06.2026 from the candidates who had appeared in Paper-II of the Examination. Accordingly, 11052 candidates who have submitted their preference online have been considered for the further selection process.

4. Representations received from the candidates with regard to the Tentative Answer Keys of Paper-II of the Examination have been carefully examined, and the Answer Keys have been modified wherever necessary. The Final Answer Keys have been used for evaluation accordingly.

5. As per the provisions of the Notice of the Examination, marks scored by the candidates in both Paper-I and Paper-II have been used for the First Round of Tentative Allocation (FRTA). As per Para 13.9 of the Notice of the Examination, the marks of Paper-I were normalized as per the formula published by the Commission vide Notice dated 02-06-2025.

5.1 Further, as per Para 13.11 and 18.2 of the Notice of the Examination, a few posts are common for Mechanical and Electrical Engineering. As the engineering branches are different, different question papers were served to the candidates of Mechanical and Electrical Engineering. Because of altogether different disciplines/question papers, difficulty levels between the two question papers may vary. Accordingly, scores of Mechanical and Electrical Engineering in Paper-II of this Examination have been normalized with each other for determining the final merit and cut-off marks.

6. As per Para 18.1 of the Notice of the Examination, minimum qualifying marks in Paper-II of the Examination are as follows:

- (a) 30% (i.e., 90 marks) for UR
- (b) 25% (i.e., 75 marks) for OBC/EWS
- (c) 20% (i.e., 60 marks) for all other categories.

7. As per Para 18.3 of the Notice of the Examination, allocation of Posts and Departments to the provisionally shortlisted candidates has been made on the basis of the performance of candidates in Paper-I and Paper-II and the preference of Posts/Departments exercised by them online. The Commission had published a list of a total 1731 final vacancies of Junior Engineer (Civil, Mechanical & Electrical) Examination, 2025 on the website of the Commission on 24.06.2026. Accordingly, a total of 1731 candidates have been provisionally shortlisted for FRTA. Category-wise breakup is as follows: -

10. **Resolution of Tie Cases:** As per Para 20 of Notice of the Examination, in cases where more than one candidate has secured equal aggregate marks in Paper-I and Paper-II, tie has been resolved by applying the following methods one after another in the given order till the tie is resolved:

- i. Total marks in Paper-II.
- ii. Marks in Part (i) of Paper-I.
- iii. Marks in Part (ii) of Paper-I.
- iv. Date of birth, with older candidates placed higher.
- v. Alphabetical order of the names of the candidates.

12. In pursuance of Para 16.4 of Notice of Examination, the Commission vide Notice dated 03.03.2026 and 08.04.2026, has introduced a 'Sliding Mechanism' to ensure maximum filling of vacancies, provide fair and merit-based opportunities to candidates and minimize the unfilled vacancies arising from non-joining of candidates in Junior Engineer (Civil, Mechanical & Electrical) Examination, 2025. **Any candidate failing to attend the sliding process physically will be treated as absent and will not be considered for the final result.** The mechanism aims to establish a single round of reallocation process for the unutilized vacancies.

12.1 Accordingly, the provisionally shortlisted candidates are to choose the venue, date and slot for the sliding process by logging in through the designated login module on the website of the Commission (<https://ssc.gov.in/>) from **12th July (05:00 PM) to 14th July (05:00 PM), 2026.** Identity Verification (IV) of the candidates selected in FRTA for exercising the option of 'FIX' and 'FLOAT' in terms of Commission's Notices dated 03.03.2026 and 08.04.2026, shall be conducted on **20th and 21st July 2026** at the cities of the Regional Offices concerned. The address of venue for the sliding process will be made available at the designated login module on the website of the Commission (<https://ssc.gov.in/>) while choosing the venue, date and slot for the sliding process. **Any candidate failing to attend the IV process physically will be treated as absent, and their candidature will not be considered for inclusion in the final result.**

13. Final Answer Keys and detailed marks of the selected/ non-selected candidates will be uploaded on the website of the Commission after declaration of final result of the Examination.
